Closing Date is November 22, 2004 or when **150** entries have been received. Fees must accompany entries. Make checks payable to Illinois & Iowa Cat Fanciers Club. No refunds after official closing date. A \$25 fee will be charged for returned checks. The entry clerk reserves the right to call collect about any entry requiring clarification.

Show Times: Check in time is from 7:30 to 8:30 A.M. Saturday and from 7 to 8 A.M. on Sunday. Judging will begin promptly at 9A.M. on Saturday and at 8:30A.M. on Sunday. Closing time is 4:30 on Saturday and 4P.M. on Sunday. You must be present to claim all final rewards unless prior written permission has been received from the Show Committee. **This is a non-smoking show hall.**

The club strongly advises immunizing all cats and kittens against Feline Enteritis, Rhinotracheitis and Calici virus at least 3 weeks prior to the show. Cats showing signs of illness and parasites will not be permitted in the show hall. An on-call vet. will be available at the owners expense.

Show Rules: ACFA show rules will govern the show. A copy may be obtained by sending \$7 to ACFA, P.O. Box 1949, Nixa, MO 65714. As per ACFA policy, we reserve the right to refuse entries which we believe will not be in the best interest of the show.

Cage/Supplies: Cat litter will be provided. Bring your own litter pans, cat food, dishes, grooming supplies and cage coverings. Transport your cat in a carrier.

The show hall is climate controlled. There are no RV hookups at the show hall. People food will be available.

Advertising: Full page \$40, Half page \$20, Business Card \$5. All copy must be camera ready and to the entry clerk by November 22, 2004.
