Show Hours: Check-In is from 7:30-8:30am CST(Chicago Time). Judging will begin promptly at 9:00am and continue through to 4:00 PM or when Judging is commenced, whichever is later. You must be present to claim final awards unless you have prior approval from the Show Manager.

Awards: Rosettes will be awarded in all rings.

Show Rules: This show will be held according to ACFA Official Rules. Please contact ACFA at (417) 725-1530 or PO Box 1949, Nixa, MO 65714-1949 for ACFA Official Rules.

Feline Health: All cats and kittens in our showhall should be immunized against feline enteritis, paleukopenia, rhinotracheitis, calcivirus and rabies at least 3 weeks prior to the show. All cats and kittens must be free of parasites or they will be removed from the show hall. They must also have all claws clipped or there will be a \$20.00 fee charged to the owner to clip them. Any entry from a household or cattery in which there has been an infectious illness within 21 days prior to show is prohibited. This is a non-vetted show and proof of the vaccinations may be required.

Show Hall: The show hall is climate controlled. People food will be available in area if not at the hall. Plenty of Free Parking is available.

Ring Clerks: Contact Pete Smith at (815) 954-0114.

Booth Space: \$40.00 for front table and \$20.00 for each side table. Space is very limited. Contact Pete Smith at (815) 954-0114 for availability.

Catalog Advertising: Full page for \$50.00, Half page for \$40.00, Quarter page for \$30.00, and Business card size for \$10.00. 50% discount for Cat Clubs and Exhibitors in the show. Ad must be Camera ready and received by December 6th.

Liability: Neither the Lake County Fairgrounds, Lake County Commissars nor TIMACS will assume responsibility for any injuries, damage or loss to any property or person. TIMACS has the right to refuse any entry and/or have any person or animal removed from the show hall for any reason deemed to be in the best interest of the show.

General Information & Sales: The summary sheet must be returned with all entries and entries fees. No sales Cage unless entered in our show. Kittens must be born on or before February 25, 2005. Show rules state no kittens less than four months of age allowed in the show hall. No cats or kittens sold for less than \$150, TIMACS Cat Club support only SERIOUS BREEDERS. No Kittens under four months. Kittens & Cats must have proof of litter registration at the show and no HHP kittens are for sale at this show. No sales are permitted from carriers under the table. Also previous cats/kittens that are brought prior to the show or to be picked up must be cleared with the show management and have a sales cage. All household pets over eight months of age must be spayed or neutered. Well-behaved children are welcome; others will be escorted from the show hall.

Supplies: Litter will be supplied. Bring your own cat food, litter pans, bowls, cage drapes, etc. Approximate cage sizes are 22"x22"x22" for a single entry and 22"x22"x44" for a double cage. Novice exhibitors should contact one of the show managers, if they have any questions.

Confirmations: If you have not received your confirmation by email/mail by June 22nd, 2005 please get hold of our Entry Clerk or our show manager to check to see if your entries have been received.
